**1. RATES OF PACKAGING HANDLING FEE**

**2. RATE OF SPECIAL PACKAGING HANDLING FEE**

**2.1.** The Packaging Company shall pay an additional **0.0300 EUR** per Packaging in addition to the handling fee(s) mentioned in clause 1 for handling special packaging.

**3. RATE OF SERVICE CHARGE OF REUSABLE PACKAGING**

The service charge is 0.0001 EUR per each sales unit in Reusable Packaging placed on market by the Packaging Company during the previous month.

**4. ACCESSION FEE**

Accession fee – **100 EUR**

**5. REGISTRATION FEE**

**5.1.** Registration fee based on the first test of registering a Packaging Article (i.e. if the Barcode of a Packaging Article immediately met the requirements set for a Barcode based on the Contract when submitted for testing) – **52 EUR** per one Packaging Article.

**5.2.** Registration Fee when registering a Packaging Article based on a repeated test – **104 EUR** per each repeated test of one Packaging Article.

**6. FEE FOR SURPASSING THE RETURN THRESHOLD**

**6.1.** The Packaging Company shall pay **0.035 EUR** per Packaging for each Packaging that surpasses the return threshold.
